## HISTORY OF ANSETT - PARAGRAPH 14 OF MY FIRST AFFIDAVIT

I refer to paragraph 14 of my First Affidavit. In paragraph 14, I describe the history of Ansett from information provided to me by Trevor Jensen. I noted that Ansett was the first Australian airline to introduce features such as "eticket" and "check-in", "SMS", and "WAP" booking services. "SMS" stands for Short Message Services, an application used on mobile telephones and "WAP" stands for Wireless Application Services.

# LETTER OF COMFORT & LIABILITIES OF THE ANSETT GROUP - PARAGRAPHS 23, 55, 79(a) & 125(g) OF MY FIRST AFFIDAVIT

In relation to paragraph 23(a) of my First Affidavit, there are no wages owing to Ansett employees. Wages were paid in full by the first Administrators and Mark Korda and me as a result of advances of AUD \$32 million made by Air New Zealand Limited to the first Administrators and us after the commencement of the administration. The payment by Air New Zealand of AUD \$32 million for Ansett employee wages ranks to priority repayment ahead of all other creditors in the Ansett Group Administration. Accordingly, Mark Korda and I negotiated with Air New Zealand Limited for this obligation to be forgiven. Air New Zealand eventually agreed to make this concession. This is reflected in the Memorandum of Understanding. The Memorandum of Understanding provides net benefit to the Ansett Group in excess of AUD \$180 million (that is the cash payment of AUD \$150 million plus the AUD \$32 million priority claims being forgiven) and other intangible benefits.

# ANSETT KICK-START - PARAGRAPHS 31, 58, 77 & 118 OF MY FIRST AFFIDAVIT

I refer to paragraph 31 of my First Affidavit where I say that Ansett Kick-Start will operate at a trading loss. The projected trading losses relating to Ansett Kick-Start are modest and have been calculated by reference to additional variable costs such as payments for leased aircraft, employees, fuel and so forth. The projected losses of Ansett Kick-Start will not exceed AUD \$15 million. However, Ansett Kick-Start is now trading in excess of the budgeted forecasts and is cash flow positive.

# ANSETT MARK II - PARAGRAPHS 34(a), 36 & 130 OF MY FIRST AFFIDAVIT

Mark Korda and I intend to use the settlement proceeds to maximise the chances of the Ansett business remaining in existence. If that is not possible, we intend to use the proceeds to maximise the return to creditors. Whilst we are continuing to develop a business model for Ansett Mark II, we expect that any recapitalisation could only occur either pursuant to or consequent upon a Deed of Company Arrangement being considered and voted upon by creditors.

# COMMITTEES OF CREDITORS - PARAGRAPH 40 OF MY FIRST AFFIDAVIT

The Bureau of Meteorology has told Arnold Bloch Leibler that it claims to be owed \$346,765.82 and not \$31,000. I stress that all the calculations of debt in my First Affidavit were prepared based on information from the creditors. I have not analysed the accuracy of the claims.

The reference to "Brierley" which appears first in paragraph 68 of my First

Affidavit is a reference to Brierley Investments Limited which has approximately a 30% shareholding in Air New Zealand.

## **NEGOTIATIONS WITH AIR NEW ZEALAND**

At paragraph 78 onwards of my First Affidavit and in particular at paragraph 81, I outline the initial discussions with Air New Zealand. The meeting was a "without prejudice" meeting. I am unable to fully set out the history of offer, counter-offer and negotiation. However it involved various offers from Air New Zealand of considerably lower sums on Air New Zealand's part than those that were ultimately agreed to. That negotiation process took in excess of nine (9) hours to complete.

# MEMORANDUM OF UNDERSTANDING - PARAGRAPH 114(d) OF MY FIRST AFFIDAVIT

At paragraph 114(d) of my First Affidavit, I attempted to summarise my understanding of how the releases contained in the Memorandum of Understanding operate. On reflection, while I believe that my interpretation is correct, it is confusing and can be restated as follows:

The Administrators and the Hazelton Voluntary Administrator release the Air New Zealand Group and all of the directors from all actions claims and demands arising out of and or relating directly or indirectly to:

- (a) The management or affairs of the Ansett Group;
- (b) Any claims arising at common law in equity or pursuant to Statute, including but not limited to the Corporations Act, the Corporations Law and the Trade Practices Act;

- (c) Any claims arising in the administration of the Ansett Group;
- (d) Any transactions or dealings between any company in the Ansett Group and any company in the Air New Zealand Group.

However, the releases do not cover:

- (a) Failure by the Air New Zealand Group or the directors to exercise their powers and discharge their duties in good faith in the best interests of the Ansett Group and for a proper purpose (within the meaning of Section 181 of the Corporations Act) or reckless conduct or improper use of the position; and
- (b) Insolvent trading type claims against the directors the Air New Zealand Group as holding company if the Ansett Group is placed into liquidation (Sections 588M and 588V of the Corporations Act); and
- (c) If any of the representations and warranties contained in clause 22 of the Memorandum of Understanding are breached.

PRESENTATION PREPARED BY ANDERSENS IN RELATION TO THE SALE OF ANSETT ASSETS - CONFIDENTIAL EXHIBIT "MFXM18A"

I refer to paragraph 120 of my First Affidavit and to Exhibit "MFXM18A" which is a true copy of the Presentation prepared by Andersens in relation to the sale of the Ansett assets. This Exhibit is confidential as it was provided

to some of the five interested purchasers of Ansett assets on a confidential basis and these persons were required to sign strict confidentiality undertakings.

## RECOMMENDATION - PARAGRAPH 129 OF MY FIRST AFFIDAVIT

I refer to paragraph 129 of my First Affidavit where I say that it is in the interests of all Ansett "stakeholders" for this transaction to proceed. The reference to "stakeholders" was intended to be a reference to "creditors" and persons who may become creditors, such as the Commonwealth Government.

## CORRESPONDENCE FROM EMPLOYEES & OTHER INTERESTED PARTIES

Peter Duffy, a non-union employee creditor of Ansett Australia Limited and a member of the Committees of Creditors sent the following email, omitting formal parts to Leon Zwier of Arnold Bloch Leibler on 10 October 2001:

"I am writing to express my support for the application in the Federal Court tomorrow (No V3045 of 2001).

I am concerned by comments raised in this mornings' newspapers by the Minister for Transport that the Federal Government requires the funds raised by this deal to be applied immediately against employee entitlements.

As an employee currently stood down and not earning an income, no issue is dearer to my heart than the full settlement of all outstanding

entitlements. I remain convinced however that the outlined Administration strategy during the Committee meeting last Wednesday and re-affirmed affidavit material provided the me in vesterday represents the best chance of success for Ansett and all creditors. The reported comments by the Minister would appear to conflict with the strategy being pursued the commercial Administrators.

Given my status as a 'non-union' employee member of the Committee of Creditors, should you believe that a useful purpose would be served by my filing an affidavit outlining my position in support of tomorrows' application, I would be delighted to assist. I can be contacted either via return e-mail or on 0407 526 212."
