

ALL TURF PRODUCERS
NEW TURF LEVY BALLOT

The Australian Government has asked that a new ballot of turf producers be conducted by the Australian Electoral Commission (AEC) in May 2006 in relation to the proposal to introduce an industry marketing and research and development levy.

All turf producers regardless of production size will be entitled to vote and are strongly encouraged to do so. If introduced, the levy will be payable only by enterprises whose annual production is 20,000 square metres or more but this limit does not affect the right to vote.

The AEC will send ballot papers to all turf production enterprises registered with Turf Producers Australia Limited or the Department of Agriculture, Fisheries and Forestry's Levies Revenue Service.
